

**RULES OF THE PROMOTION for Sabadell Blink Home and/or Car Insurance "Get €50 and then get €50 more"**  
(from 01 April 2024 to 30 June 2024)

- Promoting entity:** BanSabadell Seguros Generales, S.A. de Seguros y Reaseguros holder of Tax ID No. A-64194590 and registered offices at c/ Isabel Colbrand 22, 28050 Madrid (hereinafter, "**Promoting Company**" or "**BSSG**").
- Promotional Period:** from 01 April 2024 to 30 June 2024, both dates inclusive (hereinafter, the "**Promotional Period**"), notwithstanding this, it may be extended, suspended or cancelled by the Promoting Company at any time.
- Participants:** Banco de Sabadell, S.A.<sup>1</sup> customers of legal age and residents in Spanish territory who take out at least one the Sabadell Blink Home or Car Insurance may participate in this promotion and benefit therefrom, on the Banco de Sabadell app or website [www.bancsabadell.com/Seguros] who are holders of the **Sabadell Online Account** during the promotional period (hereinafter, the "**Participant**" or the "**Participants**").
- Promoted products:** Sabadell Blink Home Insurance and/or Car insurance contracted online with a digital account as set forth in these Rules is mediated by "BanSabadell Mediación, Linked Banking-Insurance Operator, of the Banco Sabadell Group, S.A."
- Conditions of the promotion:**
  - To be entitled to the Promotional Incentive (as set forth in clause 6 below), the Participant must be the holder of the Sabadell Online Account and take out (on the Banco de Sabadell website or app) at least one new Sabadell Blink Home or Car insurance, with a maximum effective date XX of XXXX XXXX (regardless of the date of issue or contract) and maintain it for at least one year up to date with payment. The contracting of the policies is subject to the underwriting rules of BSSG.
  - Promotion limited to the first 200 Sabadell Blink Home and/or Car Insurance contracts.**
  - The policyholders of each new Sabadell Blink policy taken out that is not of the same branch (only one policy per product will be incentivised) within the aforementioned promotional period, and whose payment is paid directly into the Sabadell Online Account, are entitled to the Promotional Incentive.
  - In the event of withdrawal from the contract by the Participant or early termination of the Contract (early termination being understood to mean termination of the contract before one year has elapsed from the date on which it came into effect), entitlement to the Incentive shall be forfeited
