## Legal Terms and Conditions

PROMOTION FOR USE OF OUR NEW BUSINESS DEBIT CARDS FOR COMPANIES AND BUSINESSES

#### 1. Scope

Banco de Sabadell, S.A. (hereinafter, the Bank) announces a prize draw among natural persons in the course of their commercial, business or professional activity resident in Spain and legal persons with registered offices in Spain, holders of the Banco Sabadell Business Debit card who use this card as a means of payment.

#### 2. Participants

The promotion and draw will be open to those who meet the following requirements:

- Be holders of or have a **Banco Sabadell Business Debit card**, or contract it during the **promotional period** and, during the same period, use it as a payment method.
- Under all circumstances, it is essential to have received notification of the promotion from Banco Sabadell by means of the leaflet or Card Carrier which will contain the Business Debit card and which will be sent out during the second half of September 2024.
- Employees of the organising company or related companies, or of the advertising agencies, or of the collaborating companies of this promotion will not be eligible to participate.

To clarify, considering the particular structure of Banco Sabadell's Business Debit cards, customers will have to contract them in the context of their business or professional activity.

The Bank reserves the right to exclude customers from the promotion if it detects any type of fraudulent conduct on their part that may alter the normal operation of the promotion.

Customers are excluded if they are in default of payment or may have any type of liquid, due and payable debt with the Bank and/or do not comply with the rest of the conditions of these terms and conditions.

Customers may choose to discontinue their participation in the promotion at any time, at their own discretion. To this effect, they should only inform their manager or office so that they can process the request.

#### 3. Promotion procedure and prizes

Customers who successfully meet the following conditions will be considered participants:

- 1. They must receive the **Banco Sabadell Business Debit card**, activate it and make purchases.
- 2. For each €50 purchase made, there will be one entry in the prize draw. The more you use the card, the more chances you have of winning the prize.

To clarify, the customer is considered to be the person who holds the card contract, not the cardholder. So, if the customer is a legal person, they will be the beneficiary of the prize.

"Purchase" is defined as any transaction made with the Banco Sabadell Business Debit card with mobile payment for the acquisition of a good or the payment for a service of consumption in a physical store, expressly excluding the payment of financing transactions, even though such may be settled as a "purchase". The cardholder must provide the Bank, if it so requests, with the supporting documentation that shows the transaction is a "purchase" as defined under this heading. • The Bank will determine the card activations made during the promotional period and will grant prize draw entries in accordance with the procedure set out above.

• The prize draw will be held in the presence of a notary on 10 January 2025. The Bank will then notify the prize winners. The winner will have until 31 January to accept the prize and submit and sign the documentation required by the Bank. After this deadline, the prize will be deemed to have been forfeited. If for reasons of force majeure the prize draw cannot be held on 10 January, it will be held on the following working day.

• Once this period has passed, and provided that the prize has been explicitly accepted, the prize will be delivered to the winner within a maximum period of 45 calendar days.

#### 5. Winner
