

Terms and conditions of the promotional offer addressed to individual customers: “200 euros for having your salary paid directly into your Sabadell Online Account”

1. Banco de Sabadell, S.A. (hereinafter, the Bank) is running a special promotion aimed at natural persons resident in Spain and Sabadell Online Account customers.

Based on this promotion they can receive:

- **200 euros¹ for new salaries paid into the Sabadell Online Account.** The amount of the new direct salary payment must be, **at least, 1,000 euros.**

All in accordance with the terms and conditions of this promotion.

Participation in the promotion entails acceptance of these terms and conditions.

2. Customers holding the Sabadell Online Account who have received a communication from the Bank by electronic means informing them of this promotion may participate.
3. Promotional validity period: **from 1 April to 30 June 2024**, both inclusive.

4. Conditions of the promotion

- The incentive consists of the payment of 200 euros¹ gross (account deposit of 162 euros) to holders who direct deposit a new salary for a minimum amount of 1,000 euros in a Sabadell Online Account during the promotional validity period.
- The salary shall be considered as having been paid directly into the Sabadell Online Account from the moment the salary is received, always on the same basis.

For the purposes of meeting the requirement, the following definitions are used:

- **Salary:** when transfers issued in accordance with the code² established for the payment of salaries under banking regulations for the clearing of transfers are received in the Sabadell Online Account. The amount of each payment must be at least one thousand (1,000) euros.
- To be entitled to this incentive, the salary must be paid directly into the Sabadell Online Account for at least 12 months. The Bank is authorised to debit the amount paid into the account if it finds that the requirements set out in these terms and conditions have not been met.
- The payment of the 200 euros¹ gross (162 euros credited to the account) will be made during the first ten days of August 2024.
- Each account holder can only receive one incentive from this promotion, regardless of the number of direct deposits they establish or whether they hold more than one Sabadell Online Account.
- The new direct deposit of the salary in the Sabadell Online Account must be made during the duration of the promotion. New direct salary payments that are salary payments in accounts held at the Bank set up prior to the promotional period and that have been cancelled during the aforementioned period are excluded, as are salary payments transferred from other Banco Sabadell Group accounts.



5. The Bank reserves the right to amend or cancel the promotion, as well as to change the date of the payment of the incentive, which will be duly reported, and to exclude from the payment any person it deems ineligible or who has acted in bad faith.
6. The terms and conditions of this promotion are governed by and subject to the laws and courts of Spain.
7. This promotion cannot be combined with any other promotional offer of the Sabadell Online Account related to the direct deposit of your salary in the Sabadell Online Account.
8. The terms and conditions of this offer are deposited and notarised before the notary public and member of the Notaries Association of Catalonia, Mr Javier Micó Giner, whose offices are calle de Narcís Giralt, no. 57, Sabadell.

Notes:

1. The net amount of the payment of 200 euros for direct deposit of salary is 162 euros. In accordance with personal income tax regulations, this amount is considered as securities income from movable capital subject to withholding tax at the currently applicable rate of 19%.
2. In accordance with the exchange rules for SEPA transfers. The purpose codes are those that appear in a standard ISO/SALA/salary list.
