

Conditions of the promotional offer designed for private customers: “200 euros for having your salary paid directly into your Sabadell Account”

1. Banco de Sabadell, S.A. (hereinafter, the Bank) is running a promotion aimed at natural persons who are Sabadell Account customers.

Based on this promotion they can receive:

- **200 euros¹ for a new regular salary payment into the Sabadell Account.** The amount of the new regular salary payment must be, **at least, 1,000 euros.**

All in accordance with the terms and conditions of this promotion.

Participation in the promotion entails acceptance of these terms and conditions.

2. All customers who hold a Sabadell Account can participate if they adhere to promotion by going to any of the Bank's branches or if they have been contacted by the Bank via electronic means informing them thereof.
3. Promotion validity period: **1 April to 30 June 2024**, both dates inclusive.

4. Terms and conditions of the promotion:

- The incentive consists of the payment of 200 euros¹ gross (the account will be credited with 162 euros) to account holders who directly get a new salary paid into their Sabadell Account for a minimum amount of 1,000 euros during the promotional period.
- The salary shall be considered as having been paid directly into the Sabadell Account from the moment the salary is received, always on the same basis.

For the purposes of meeting the requirement, the following definitions are used:

- **Salary:** When transfers issued in accordance with the code² established for the payment of salaries under banking regulations for the clearing of transfers are received into the Sabadell Account. The amount of each payment must be at least one thousand (1,000) euros.
- To be eligible for this incentive, the salary must be paid directly into the Sabadell Account for at least 12 months. The Bank is authorised to debit the amount paid into the account if it finds that the requirements set out in these terms and conditions have not been met.
- The payment of the 200 euros¹ gross (162 euros credited to the account) will be made during the first fifteen days of October 2024.
- Each account holder can only receive one incentive from this promotion, regardless of the number of direct deposits paid into the accounts held with the Bank or whether they hold more than one Sabadell Account.
- The new salary payment into the Sabadell Account must be set up during the duration of the promotion. New direct deposits corresponding to direct deposits with the Bank established prior to the promotional period and that have been cancelled during said period are excluded, as are direct deposits transferred from other Banco Sabadell Group accounts.

5. The Bank reserves the right to amend or cancel the promotion, as well as to change the date of the payment of the incentive, which will be duly reported, and to exclude from the payment any person it deems ineligible or who has acted in bad faith.
6. The terms and conditions of this promotion are governed by and subject to the laws and courts of Spain.
7. This promotion cannot be combined with any other Sabadell Account promotional offer related to having their salary paid directly into their Sabadell Account.
8. The terms and conditions of this offer are deposited and notarised before the notary public and member of the Notaries Association of Catalonia, Mr Javier Micó Giner, whose office address is calle de Narcís Giralt, no. 57, Sabadell.

Notes:

1. The net amount of the payment of 200 euros for direct deposit of salary is 162 euros. In accordance with personal income tax regulations, this amount is considered as securities income from movable capital subject to withholding tax at the currently applicable rate of 19%.
2. In accordance with the exchange rules for SEPA transfers. The purpose codes are those that appear in a standard ISO/SALA/salary list.
